Subject	Minutes of the Meeting of District Development Committee of Kamrup District
Date & Time	26/09/2025 at 11.30 AM
Venue	Conference Hall of O/o District Commissioner, Kamrup.

The meeting was chaired by Sri Deba Kumar Mishra, ACS, District Commissioner, Kamrup. The meeting started with welcome address from Sri Susanta Kumar Dutta, ACS, DDC, Kamrup followed by seeking action taken report on issues from earlier meeting.

At the outset, Sri Deba Kumar Mishra, ACS, District Commissioner, Kamrup welcomed all members present in the house and desired to go for inter-departmental issues before proceeding to departmental review.

Inter-departmental issues:

1. EE, PWD, NKTRD informed that road construction near Dumnichowki High School has been affected because of its boundary wall leading to a sharp 90 degree turn which may lead to road accident. DC directed Inspector of Schools to demolish the wall in coordination with BDO Bezera, GP President and school authority and local people for creating smooth and safe movement of the traffic.

2.EE, PWD, NKTRD raised that for shifting of the Electrical Pole in Balisatra PWD road compensation from the department has already been made but no action has been take by APDCL authority in this regard and moreover APDCL without any communication has started digging. DC instructed the AGM APDCL to make necessary arrangement for shifting of electrical immediately and instructed to communicate with concerned authority before sanctioning any work.

3.EE, PWD, SKTBD requested for conversion of the Grazing land allotted to construction of IIM in Rampur. DC informed that 574 bighas of land proposed for aquisition has been placed before LAC Board for approval.

4. DC directed EE, PWD, NKTRD and EE, PWD NKTBD to convene a meeting immediately on 26/09/2025 evening with the Contractor of ACA Stadium at Amingaon for clearing of the mud dump deposited in the road before the start of BWF World Championship.
