Subject	Minutes of the Meeting of District Development Committee of Kamrup District
Date & Time	6 th of January, 2025 at 11:00 AM
Venue	Conference Hall of O/o the Tourism Development Officer, Rajapara, Chandubi

The meeting was chaired by Sri Deba Kumar Mishra, ACS, District Commissioner, Kamrup. The meeting started with welcome address from Sri Susanta Kumar Dutta, ACS, DDC, Kamrup followed by seeking action taken report on issues from earlier DDC meeting as follows:

- DDC, Kamrup enquired Irrigation, Boko-Chaygaon Div, regarding submission of list of defaulter beneficiaries in paying Electricity bill against the electric pumps provided under PMKSY. Representative from APDCL informed that they are analysing the default amount and steps to be taken up soon for waiving of interest payment in Lok-Adalat.

- Chairperson enquired about the functioning of PPC notified in Sontoli to which the representative of Agriculture replied that paddy is procured by the Centre at expected rate.

- Chairperson also directed EE, PWD (Electrical) to access the difficulty and propose an action plan to install separate meters for each departmental establishment in Integrated District Office, Kamrup. DDC, Kamrup requested all concerned HODs to plan and coordinate on the matter and consult ADC (Nazarat).

- EE, PHED apprised the House that verification of 50% of the IHHL beneficiary under SBM is to be completed by this month and requested concerned BDOs to take up the matter with GP Secretaries. Chairperson instructed BDOs to detail GP Secretaries for completion of verification process. (Action : All BDOs)

- EE, PWD, Hajo-Sualkuchi TRD informed the House that Agyathuri Ganesh Mandir Road is damaged by some unknown person and FIR has been lodged regarding the matter. EE requested District Authority to extend support and vigilance regarding the matter. Chairperson asked the Official to submit a copy of FIR to District Authority so that matter can be taken up with SP, Kamrup.

- Chairperson also discussed about importance of Vulture Conservation and opined to conduct a meeting with District A.H & Vety. Officer, concerned Forest Officer and representative of Organisation that is currently working actively for Vulture conservation. (Action: DVO)




