

**MINUTES OF THE DDC MEETING HELD ON 2<sup>nd</sup> August 2022 IN THE CONFERENCE HALL OF THE OFFICE OF THE INTEGRATED DEPUTY COMMISSIONER'S OFFICE, KAMRUP, AMINGAON.**

The meeting was chaired by Smti Keerthi Jalli, IAS Deputy Commissioner, Kamrup along with Sri Norsing Bey, ACS District Development Commissioner, Kamrup , Sri Parag Kakati Project Director DRDA along with other district heads. After a brief introduction of all the Heads of the Department , Deputy Commissioner appraised the house that as a part of the celebration of 75<sup>th</sup> Independence Day and as decided by the Cabinet Meeting all Govt. Offices, Beneficiaries SHG, Individual Houses etc should observe Har Ghar Tiranga. In this regard CEO Zila Parishad read out the SOP for the same.

DDC Kamrup read out the monitorable targets of the recent DC- SP conference held at Tezpur and requested all HODs to submit their Action Taken report on the same for necessary and timely monitoring of the monitorable targets.

After a threadbare discussion the following key points were recorded as follows:

1	EDUCATION	DEEO inquired regarding the matter relating to the electrification of the 5 schools for the successful implementation of the Jal Jeevan Mission in schools and Anganwadi Centres, completion of the electrification process should be completed. on this officials from APDCL informed that out of 5 schools electrification has been completed in 4 schools and the one not completed is in the Char Area and solar panel should be fixed in that school , procurement of Solar Panels is in process . However DDC, Kamrup instructed the APDCL officials to ensure whether the pumps has the load capacity to power the JJM installed pumps. The matter relating to the repairing of all the dilapidated AWC was discussed and DDC, Kamrup informed that internal electrification should be done by District Social Welfare Officer, Kamrup	DEEO,KAMRUP APDCL DSWO, KAMRUP
2	All HODs	DC Kamrup instructed all the Head of the Department, that all pending compassionate ground appointment proposals should be submitted after all necessary formalities and the same should be resolved at the earliest. DC, Kamrup also instructed the HODs that since all details are needed to be linked with ADHAAR, as such ADHAAR details should be collected by all departments when implementing beneficiary oriented schemes. 3	PHE Guwahati Division	DDC, Kamrup informed the Executive Engineer, PHE Guwahati Division I that as per their report though out of 227 nos of Installation of Hand Tube Well with Platform under EC 119 under Hajo MCB	1. EE. PHE Guwahati Division

		with unit cost of Rs 15,000/-, 190 Hand Tubewell has been completed, not a single Hand Tubewell can be found at the pin point location by the Hajo BLF. DDC, Kamrup instructed to carry out a joint inspection along with the BLF and submit report before the next DDC meeting.	
4.	Tourism	The Tourist information officer, Kamrup informed the house that due excessive increase of water weeds in Chandubi Beel, the water level has gone down reducing the viability of boating in Chandubi Beel. As Chandubi Beel has a wide tourist attraction as such, the receding of water level is a matter of concern and needs immediate attention.	
5	APDCL	Regarding the matter relating to the heightening of the electrical poles in the construction site of the scheme, "Const. of library room near Singimari Habi Water Supply" taken up in the AAGY village under Goroimari Block, the officials from APDCL informed that the survey of the site has been completed and the work would be started at the earliest. Before ending the meeting DDC, Kamrup requested all the members present in the meeting to extend full co-operation for the success of Har Ghar Tiranga. He also informed that several sale points has been installed at different locations for procurement of the National Flag. He also informed that all Govt, Offices should use the standard size Flag for their offices and necessary requirement of Flags should be given in advance so that all the required number of Flags can be made by the SHGs and deliver on time.
