The meeting was chaired by the Deputy Commissioner, Kamrup welcoming the participants the Deputy Commissioner and Chairperson, DDMA, Kamrup said that the season's second DDMA meeting was called to finalize the remaining Flood damage proposals under SDRF submitted by the Circle Offices and various line departments for the year 2022.

The Deputy Commissioner laid down responsibilities to Circle Officers and various departments on the implementation of highlighted tasks as mentioned below in the table:

The Additional Deputy Commissioner and CEO, DDMA quoted that in the 2<sup>nd</sup> DDMA meeting today the remaining damage proposals from Revenue Circles and line departments will be considered for approval.

## **DAMAGES FOR FLOOD:**

Regarding the Flood Damage proposals, the DDMA has given "In-Principle Preliminary Approval" for the damage proposals submitted today for:

- i) House damage for Rangia, Kayan, Kamalpur, Hajo, North Guwahati and Chamaria Revenue Circles.
- ii) Line Department damages from Education, Health, Social Welfare, Water Resource, PWD (Roads), PHED, Agriculture, Fishery and Veterinary departments were given "In-Principle Preliminary Approval" by DDMA.
- iii) The Model Estimate for repairing and renovation of Anganwadi Centers damaged in flood prepared by a Technical Committee constituted by the Chairman, DDMA.

The list of Beneficiaries has been attached as Annexure A.

The Damage Proposals for the line departments have been attached as Annexure B.

The Deputy Commissioner put forward the following Observations which needs to be strictly adhered to:

- 1. Guidelines for the allotment of funds as per SDRF norms as regards to PWD (Roads) needs to be checked.
- 2. The concerned School Administration will be responsible for students availing the Book Grant of Rs. 1000/- and submit a report on the number of beneficiaries (in the school) to the concerned BEEO and the BEEO will submit the same to the concerned Circle Officer.
- 3. Cross check all Bank account details of the beneficiaries under Utensil and Cloth, House damage and Book Grant.
- 4. The Gaon Pradhan along with the VLMCC members will visit the houses of affected families and take photographs and submit lists of the partially, severely and fully damaged houses.
- 5. Under 15<sup>th</sup> Finance Commission, and other schemes including Adarsh Gram Yojna, there are multiple efforts to repair the Anganwadi Centers. The list which is approved by the DDMA, will be shared with the concerned BDOs to ensure there is no duplicate or dual spending for repairs of the same nature under two different schemes of the Government.
- 6. All damaged proposals under SDRF budget sanctioned under SDRF for immediate restoration should be completed within 3 months.
- 7. Prioritize the schemes to be included under SDRF based on scientific criteria.
- 8. All infrastructural damages of line departments during floods should be reflected in the FRIMS report, to facilitate accord of sanction by Government under SDRF.
- 9. All APRs related to expenses in Flood should be submitted on or before 31st July, 2022.
- 10. Maintain a Master Register of the people who lived in 'relief camps' and 'camp like situation'.
- 11. Rangia, Kayan and Kamalpur Revenue Circles under Rangia Civil Sub-division should submit all APRs and Certificates related to GR distribution to SDO (Civil), Rangia and UC of Contingency money to DDMA.

- 12. Private Citizens also to be included in the selection lists of people who have done exceptional work in flood 2022 and submit it on 13<sup>th</sup> July, 2022.
- 13. Payments to vehicles used for flood relief / duty should be submitted as per "Government Verified Rates". For special cases where rates may vary, Speaking Orders are to be issued from concerned departmental heads with proper justification.

The Deputy Commissioner also requested the Hon'ble MLAs to help in the process of damage assessment so that the genuine people who are entitled for the compensation grants gets their due share.

It may be mentioned here that all the above mentioned proposals submitted by the various Departments and RG proposals submitted by the Circle Officers were approved in the Circle Level Task Force meeting for accord of sanction in DDMA under SDRF for Infrastructural and House damaged in flood. The Deputy Commissioner concluded that the 3<sup>rd</sup> and final DDMA meeting will be held on 13<sup>th</sup> July, where all damage proposals for flood 2022 will be finalized and after that no proposals will be accepted.

The meeting ended with a vote of thanks from the chair.
