## Minutes of the meeting of the DDMA, Kamrup for approval of Damaged Proposals (for Flood/Storm damage) under SDRF submitted by various Departments in Kamrup District on 13th July, 2022 at 10.30 am in the Conference Hall of the Office of Deputy Commissioner, Kamrup.

Venue: Office of the Deputy Commissioner, Kamrup.

Date & Time: 13th July, 2022 at 10.30 am.

Participants: at Annexure-I.

The meeting was chaired by the Deputy Commissioner, Kamrup welcoming the participants the Deputy Commissioner and Chairperson, DDMA, Kamrup said that the season's third and final DDMA meeting was called to finalize the remaining Flood damage proposals under SDRF submitted by the Circle Offices and various line departments for the year 2022. He informed the Hon'ble Guardian Minister present in the meeting that 30 % of the damage proposals were given 'in principle approval' in the 1st DDMA meeting held on 1st July, 50%-60% damage proposals were approved in the 2nd DDMA meeting held on 8th July and the remaining will be accorded approval in the 3nd and final DDMA meeting today. Apart from that all infrastructure damages submitted from various line departments were considered for accord of "in-principle approval. All the lists of beneficiaries selected under various categories of Government grants were hung in prominent public places like schools for ensuring maximum transparency and public scrutiny.

The Deputy Commissioner laid down responsibilities to Circle Officers and various departments on the implementation of highlighted tasks as mentioned below in the table:

ii) Line Department damages from Education, Health, Social Welfare, Water Resource, PWD (Roads), PHED, Agriculture, Fishery, APDCL, Handloom & Textile, Veterinary, P & RD and Irrigation departments were given "In-Principle Preliminary Approval" by DDMA.

The Damage Proposals for the line departments have been attached as Annexure B.

## Deliberations from Hon'ble Gurdian Minister:

- Hon'ble Guardian Minister disclosed that Chief Minister has declared that all schools will get a grant of Rs. 3 crores for infrastructure development.
- He directed the Veterinary department to start health camps immediately in the district specially starting with Nagarbera rev. circle where animals are dying due to some endemic.
- Circle Officers to put forward proper justification regarding the beneficiaries getting GR
  grant for utensils and clothing which is less than the beneficiaries getting RG grant for house
  damage.

The Deputy Commissioner reiterated the following Observations which needs to be strictly adhered to:

- 1. Guidelines for the allotment of funds as per SDRF norms as regards to PWD (Roads) needs to be checked.
- 2. Cross check all Bank account details of the beneficiaries under Utensil and Cloth, House damage and Book Grant.
- 3. The Gaon Pradhan along with the VLMCC members will visit the houses of affected families and take photographs and submit lists of the partially, severely and fully damaged houses.
- 4. All damaged proposals under SDRF budget sanctioned under SDRF for immediate restoration should be completed within 3 months.
- 5. All infrastructural damages of line departments during floods should be reflected in the FRIMS report, to facilitate accord of sanction by Government under SDRF.

- 6. Maintain a Master Register of the people who lived in 'relief camps' and 'camp like situation'.
- 7. Private Citizens also to be included in the selection lists of people who have done exceptional work in flood 2022 and submit it on 13th July, 2022.
- 8. Payments to vehicles used for flood relief / duty should be submitted as per "Government Verified Rates". For special cases where rates may vary, Speaking Orders are to be issued from concerned departmental heads with proper justification.

It may be mentioned here that all the above mentioned proposals submitted by the various Departments and RG proposals submitted by the Circle Officers were approved in the Circle Level Task Force meeting for accord of sanction in DDMA under SDRF for Infrastructural and House damaged in flood. The Deputy Commissioner concluded that today is the final DDMA meeting held, where all damage proposals for flood 2022 will be finalized and only in case of any exceptions proposals will be accepted.

At the end Hon'ble Guardian Minister highly appreciated team Kamrup for managing the flood disaster very meritoriously and commendably.

The meeting ended with a vote of thanks from the chair.
