Prohibitory Order u/s 163 BNSS

Whereas, ensuing Dipawali/Kali Puja on the 31st October & 1st November, 2024 and the Chath Puja on the 7th November, 2024 will be celebrated across the country as well as in Kamrup District;

And.

Whereas, during the course of the celebration of the festival there is likelihood of bursting of firecrackers in public places and public thoroughfares, which if unregulated will significantly affect the air quality and will produce a large volume of noise;

And,

Whereas, bursting of crackers leads to increase air pollution which will have an adverse impact on health, and hence it is deemed necessary to ban certain categories of fire crackers and restrict the timing for usage of all others;

And.

Whereas, the Hon'ble Supreme Court of India vide order No.44727/2021 in WRIT PETITION (C) No.728/2015 dated 29.10.2021 has noted that air pollution from all sources has to be contained, and hence there is a need to restrict the usage of firecrackers,

And,

Whereas, the Government of Assam has also directed that the sale and usage of foreign made fire cracker are strictly prohibited;

Now, therefore, I, Shri Deba Kumar Mishra, ACS District Magistrate, Kamrup District, Amingaon, in exercise of the powers conferred upon me under section 163 BNSS, do hereby prohibit -

- 1. The sale, purchase and procurement of foreign-made firecrackers;
- 2. The sale, purchase and procurement of firecrackers Barrium & other chemicals banned by the Apex Court of India;
- 3. Bursting of fire crackers in any part of the district between 10:00 p.m. to 08:00 a.m. w.e.f. 31.10.2024 till 02.11.2024;
- 4. The Use of firecrackers generating noise level exceeding 125 db (AI) of 145 db (C) PK at 4 meters distance from the point of bursting;
- 5. Bursting of crackers within 100 meters of hospitals, nursing homes, primary and district health care centers etc.;
- 6. Further, the sale of fire crackers shall only be through licensed traders and it shall be ensured that these licensed traders sell only those firecrackers which have been permitted by this office and are incompliance to central pollution control board guidelines;
- * However, there is no obligation on bursting of green crackers (of noise level < 125 db (AI) of 145 db (C) PK) by public between 08:00 p.m. to 10:00 p.m. on the 31st October, 2024.

As circumstances do not admit of serving of a notice upon any individual(s) or organization(s), as provided u/s - 153 BNSS, this order is being passed ex-parte as envisaged U/S 163 (2) BNSS and it shall come into force with immediate effect and remain in force till the celebration of the festival is over.

Anyone aggrieved with this order is/are at liberty to approach the undersigned for any modification / altercation / resceind of this order. Violation of this promulgation will be punishable under section 223 of BNS and any other existing relevant provisions of law. The Superintendent of Police, Kamrup shall ensure implementation of this order in letter and spirit.
