Prohibitory Order u/s 163 BNSS

Whereas, it has been made to appear to me that some people or groups of people are illegally cutting, illegally carrying sand / earth / boulders from different hills / river beds / wetlands of the district causing imminent danger of erosion / landslides / blockage of drains, extensive danger to the life and property of people residing in the adjoining area/ areas, and also irreparable damage to the environment and loss of government revenue;

- And -

Whereas, it has also been made to appear to me that Government of Assam has prohibited cutting of earth in hills / river beds / wetlands areas in the state of Assam by enacting "The Assam Hills and Ecological Sites Protection Act, 2006";

- And -

Whereas, in spite of this, it appears that illegal cutting of earth in hill areas in different places of Kamrup District is quite rampant;

- And -

Hence, being so satisfied with the contention stated herein above, I, Shri Deba Kumar Mishra, ACS, District Magistrate, Kamrup, Amingaon in exercise of powers conferred upon me u/s - 163 BNSS, do hereby prohibit illegal cutting, illegal procurement, illegal transportation of Hill (Red) soil and earth from other ecologically protected areas from all hills of Kamrup district with immediate effect and until further orders.

The Superintendent of Police, Kamrup shall ensure implementation of this order in letter and spirit. Violation of this promulgation will be punishable under section 223 of BNS and any other existing relevant provisions of law.

As circumstances do not admit of serving of a notice upon any individual(s) or organization(s), as provided u/s – 153 BNSS, this order is being passed ex-parte as envisaged U/S 163 (2) BNSS and it shall come into force with immediate effect and remain in force until further notification.
