Prohibitory Order u/s 163 BNSS

Whereas, it has been observed that car drivers and two wheeler riders and pillion are driving / riding without seat belts / helmets endangering their lives as well as threatening the lives of the others particularly the roadside walkers;

- And -

Whereas, driving / riding without seat belts / helmets is an offense under the Motor Vehicles Act;

- And -

Whereas, District Administration has taken a serious note of such issues and in order to ensure better road discipline and to deal with such violators of traffic laws, some additional stringent measures should be placed in the larger interest of public;

- And -

Whereas, the car driver / two wheeler rider enters petrol pump station / filling station to refill fuel of their vehicles by contra flow driving resulting traffic congestion in the premises of petrol pump station / filling station;

- And -

Now, therefore, in view of the above, I, Shri Deba Kumar Mishra, ACS, District Magistrate, Kamrup, in exercise of the powers conferred upon me under section 163 of the BNSS, do hereby promulgate the following the orders with immediate effect throughout the Kamrup District in the interest of security and safety of health and life of public at large:

- 1) No Petrol Pump Station / Filling Station in Kamrup District shall sell / refill the fuel to any car driver / two wheeler rider who is not wearing seatbelt / helmet and a rule of "NO SEATBELT / HELMET, NO FUEL" shall be enforced within the jurisdiction of Kamrup District.
- 2) No petrol pump station / filling station shall sell / refill the fuel to any car driver / two wheeler rider who enters the petrol pump station / filling station by contra flow driving.
- 3) All Petrol Pump owners shall compulsorily install the CCTV Cameras with DVR in their fuel outlets clearly indicating the footage of fuel buyers. All the Executive Magistrates are authorized to check the footage of petrol pumps / filling stations and recommend actions against the defaulters of the undersigned.
- 4) Time Period of ten days is given to all the petrol pumps /filling stations for installing CCTV cameras for proper recording of Car Driver / Two Wheeler fuel buyers.
- 5) The Circle Officers in their respective territorial jurisdiction shall execute this order and cause the service of this order upon all petrol; pumps with intimation to the undersigned.
- 6) Appropriate action as warranted under laws shall be taken against Petrol Pumps selling fuel to such traffic violators.

As circumstances do not admit of serving of a notice upon any individual(s) or organization(s), as provided u/s - 153 BNSS, this order is being passed ex-parte as envisaged U/S 163 (2) BNSS and it shall come into force with immediate effect and remain in force until further order.

Anyone aggrieved with this order is/are at liberty to approach the undersigned for any modification / alteration / rescind of this order. Violation of this promulgation will be punishable under section 223 of BNS and any other existing relevant provisions of law.

The Superintendent of Police, Kamrup shall ensure implementation of this order in letter and spirit.
