Criteria: The appointment shall be governed by the provisions of the Assam Land and Revenue Regulation, 1886 and the Executive Instructions contained in the Assam Land Revenue Manual (Chp. VIII, under clause 115,115-A,115-B,115-C,116,116-(A)) as amended from time to time.

A candidate applying for appointment to the post of Mouzadar of Pub Chamaria Mouza shall satisfy the following conditions:

1. The candidate shall be a citizen of India and a permanent resident of Assam.
2. Preference shall be given to candidates ordinarily residing within the jurisdiction of Pub Chamaria Mouza and having adequate knowledge of the local area, land revenue administration and revenue-paying pattadars of the Mouza.
3. In terms of Executive Instruction No. 116 of the Assam Land Revenue Manual, the successor to a Mouzadar shall ordinarily be selected from amongst the members of the family of the outgoing Mouzadar, including relations on the female side where no qualified male heir is available, subject to suitability and merit. However, such preference shall not confer any absolute right of appointment. The appointing authority shall be at liberty to select any other candidate found more suitable in the public interest.
4. Qualifications for appointment to the post of mauzadar will include a fair vernacular education, such as is required for the keeping of the mauzadari accounts. It is desirable that the education should have extended to the middle vernacular standard. Further, other things, being equal, preference shall be given to candidates who have higher educational qualifications such as those connected by matriculation or higher passes (116-(v) of the Executive Instructions contained in the Assam Land Revenue Manual).
5. The candidate shall be of sound health, good character and free from any criminal conviction involving moral turpitude.
6. The candidate shall not be a defaulter in payment of Government revenue, land revenue, taxes, public demands or any dues payable to the Government.
7. Preference may be given to candidates having previous experience in management of Mouza affairs, revenue administration, public administration, social service or other public sector activities.
8. Any person for appointment as mauzadar shall be disqualified, if he/she holds any office of profit under the Government (116-A of the Executive Instructions contained in the Assam Land Revenue Manual).
9. The District Commissioner, Kamrup, Amingaon reserves the right to reject any application without assigning any reason and to determine the suitability of candidates. The decision of the District Commissioner shall be final in all matters relating to scrutiny of applications, eligibility and selection.
10. The selected candidate shall, within the prescribed period, execute the required affidavit, furnish the prescribed security and comply with all conditions laid down under the Assam Land Revenue Manual and Government instructions, failing which the offer of appointment shall be liable to cancellation.

Note:-

- Candidate must carry all testimonials in original at the time of interview.
- No TA/ DA will be admissible for appearing in the interview.
- The date, time and venue of the Viva Voce interview will be published through official website and Call Letter will be issued to each candidate accordingly.
- No request for admission for participation in the interview on another day will be accepted in case candidate fails to attend the interview on the scheduled date.
- Eligible candidates scoring highest marks in the Viva Voce will be selected for the post of Mouzadar for the Concern Mouza.
- The decision of the District Commissioner, Kamrup, Amingaon as to the eligibility or otherwise of a candidate for admission to the interview venue shall be final.
