As per Section 6 of Assam Hill Land and Ecological Sites (Protection and Management) Act, 2006, the following are the powers and functions of the Advisory Committee:

- i. To recommend to the Government any matter regarding administration and management of the Designated Area;
- ii. to recommend the matters, which are, required to be included in the Management Plan.
- iii. To suggest measures concerning removal of encroachments from the Designated Area;
- iv. To facilitate research works for the development and protection and further prospect of the Designated Area;
- v. to take necessary action for improvement, protection and promotion of the Designated area,
- vi. To do any work as may be assigned to it by the Government for carrying out the
